In addition, please refer to paragraphs 1.18 -21 setting forth IsDB's policy on conflict of interest.
4. Interested eligible bidders may obtain further information from *the Procurement Office* and inspect the bidding documents during office hours. *08:00 to 17:00 hours (local time)* at the address given below.

A complete set of bidding documents in English may be purchased by interested eligible bidders upon the submission of a written application to the address below and upon payment of a nonrefundable fee of **one hundred and thirty thousand (130 000) F CFA**. The method of payment will be to CAS-ARMP Account No. **97568660001 - 28** in any BICEC Bank Branch.

6. Bids must be delivered to the address below on or before **Friday, 2nd October 2020 at 10:00 am**. Electronic bidding will not be permitted. Late bids will be rejected. Bids will be publicly opened in the presence of the bidders' designated representatives and anyone who choose to attend at the address below on **Friday, 2nd October 2020 at 11:00am**.
